<u>ORDER</u>

1. As per paper read (1) above, the University had invited applications for continuation of provisional affiliation for the academic year 2021-22 from colleges for courses affiliated to this University. The Principal, DM Wayanad Institute of Medical Sciences-MM024 has submitted application for the continuation of provisional affiliation for the year 2021-22 vide paper read (2) above.

2. The college, vide paper read (3) above, has obtained recognition from the Ministry of Health and Family Welfare Department, Govt. Of India for conducting the MBBS course with an intake of 150 seats for the Academic year 2021-22.

3.Considering the situation due to COVID 19 Pandemic, the 62nd meeting of the Governing Council held on 26-12-2020 vide decision No. 62.16 has decided to give one time exemption to the colleges satisfying any of the following conditions from inspection for the grant of continuation of provisional affiliation for the academic year 2021-22 vide paper read (4) above

i. The colleges whose first batch of all courses are passed out and no major/minor deficiencies were pointed out during inspection conducted for the grant of continuation of provisional affiliation during the academic year 2019-20 and inspections were not conducted for the grant of continuation of provisional affiliation during 2020-21.

ii. The colleges whose first batch of all courses are passed out and no major deficiencies/no major deficiencies but with minor deficiencies/no deficiencies were pointed out during the inspection conducted for the grant of continuation of provisional affiliation during 2020-21.

iii. The colleges which will satisfy any of the above two conditions, if exempting the norm that the first batch of the students of all courses admitted in the college under EWS quota in various UG/PG courses a nd /or under super specialty courses (starting/enhancement of seats) were passed out.

4. As the college belongs to the category (ii), the 63rd meeting of the Governing council vide decision read (5) above has decided to grant Continuation of Provisional Affiliation to DM Wayanadu Institute of Medical Sciences, wayanadu for conducting the MBBS course with 150 seats for the Academic Year 2021-22.

- Selection, admission and collection of fees shall be made only on the basis of the rules and 1 regulations of the University/Govt. of Kerala and on the basis of the direction issued by the University from time to time, failing which the affiliation granted will be cancelled.
- 2 In the light of the direction of the Supreme Court of India in Writ Petition(c) 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent the instances of ragging, appropriate action including withdrawal of affiliation of the College will be initiated.
- 3 Affiliation granted is strictly provisional and only for the academic year 2021-22. The college has to apply for continuation of provisional affiliation for the ensuing years remitting the fee fixed by the University, along with a copy of letter of approval from the apex bodies concerned.
- 4 The College should remit annual administration fee fixed for UG/PG course for the academic year and the college should submit the order reconstructing the College Council for the 2021-22 Academic year 2021-22 at the time of Student registration.
- 5 Admission to the next academic year shall be made only after obtaining prior permission from the University.
